1. A word from the editorial board

The term “crisis” is too frequently used. Consequently, it lacks precision and may have lost its intended original meaning. However, we are particularly interested in looking at the different crises that have challenged the creation of the European Union as a legal order and the Union’s ability to resist or cope with the different crises that it continues to face. For example, the EU is currently overwhelmed by *institutional* crises (“Brexit”), *governance* crises (monetary, economic and budgetary policies), and *liberties* (massive population movement). It is lasting institutions that promote good governance, and ultimately the exercise of our liberties.

2. A word from the executive director

The crisis affecting Europe and its integration process is profound and manifold.

In addition to a protracted economic crisis, Europe is facing a migration crisis and many difficulties linked to the arrival of numerous migrants on the European territory, a crisis of democratic values in certain countries such as Hungary and Poland, a crisis of political representation and trust in the elites in many European states, and a crisis linked to national security and defense to face the growing threat of terrorism.

The situation gives cause for concern on two fronts.

On one hand, it has provoked and revealed mistrust, and fierce differences of opinion among European partners, which has, in certain states, put in doubt the membership in the common entity of the Union.

On the other hand, it has created within the European population a sentiment of rejection *vis-à-vis* the European idea and the integration project.

The paradox is that the revelation of this division and subsequent reject are developing in the context of a rising economic and societal interdependence among the European states.

The crises have revealed that interdependence is not enough to create an efficient and stable environment for a common entity. In fact, during periods of crisis, to the contrary, it can contribute to the rousing of tensions.

The questions that we would like to address in this volume are the following: How do we go beyond the notion of interdependence? Can we take into account our factual interdependence to reshape and reinforce the collective European experience? Which instruments and which concept does the law offer to carry out this reassessment?

It appears to us that all these crises are intimately linked. In light of this, we will pay particular attention to the contributions that reveal these links.

Latin phrases and maxims:

- *Confer, cf.*: is used to replace « see ». For coherence of the text, one must choose either « *cf.* », or « *see* » for the entirety of the text. One must not alternate between the expressions. One may directly used the shortened abbreviation *cf.* (Unlike the usage of *idem* and *ibidem*, it is permissible to use the shortened version on the first citation).
- *Ibidem, ibid.* : Only if citing something from the previous footnote on the same page. Normally, the abbreviation *Ibid* is used after *Ibidem* has been used previously.

 - *Ibidem*.
 - *Ibid.*
- *Idem, id.* : Used only if a precise reference has been used in the previous note and the author would like to refer to the same work, but to a different page (ex: *idem*, p. 42). Normally, the abbreviation *id.* after having previously used *idem*.

- *Supra.* : Utilized to refer to a reference previously cited; *supra.* is used for the source and not for the author. Please precise the note to which the first reference alluded.
 - Christine Fauré, *supra.* note 12, p. 23.
